You choose to search your inbox...

You remember the email. You're sure it was sent. But now you're 10 minutes deep in your inbox, juggling keywords, sender names and folders. It's not turning up.

Maybe it was deleted. Maybe it was sent to someone else. Maybe the person who wrote it left the company. Either way, it's not in front of you.

You can't prove the spec change happened. You can't show who approved it. You can't even confirm when it was made.



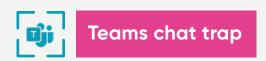
Result: You can't prove anything.

You check the Teams chat...

You remember the conversation. It was agreed in the chat, late one Friday. But when you scroll back, it's gone, buried in months of back-and-forth. No thread. No summary. No record of approval.
